A cattle rancher by trade, Richard Pombo previously served in the U.S. House of Representatives for 14 years and was Chairman of the House Resources Committee from 2002-2006. Pombo earned national attention as a champion of private property rights and as a leader against intrusive and overreaching big government. Pombo was a key author and the driving force behind passage of the Energy Policy Act of 2005— encouraging Americans to use domestic resources for energy production and reducing our dependence on foreign supplies. He also authored and passed landmark reform of the Endangered Species Act in the House – unfortunately, the bill was defeated by a coalition of liberal Republicans and Democrats in the Senate. Pombo is seeking a return to Congress in the 19th district of California.
