Federal law requires political committees to use their best efforts to obtain the name, mailing address, employer and occupation for each individual whose individual contributions exceed \$200 in an election cycle. Individuals may contribute a maximum of \$4,800 - \$2,400 for primary election and \$2,400 for general election. Federal PACs may give a maximum of \$10,000, \$5,000 for primary and \$5,000 for general election. Corporate contributions are not permitted. Contributions are not deductible as charitable contributions for federal income tax purposes.
